NOW THEREFORE BE IT RESOLVED, the Coffman Cove City Council hereby accepts and approves the attached policy and disclaimer for right of way firewood in Coffman Cove.

City of Coffman Cove **ROW Firewood Permit Policy**

Persons obtaining the permit will agree to clean up debris left after firewood is removed. When resident is ready to collect firewood, a City Staff member will be appointed to show what areas wood is available. No permit will be issued without a signed liability disclaimer. The City is not responsible for any damage, personal injury, etc.

- Permits are required for all ROW Firewood Cutting
- Cost of permit will be \$50 per year
- Permit holder is allowed a maximum of 10 cord
- The Permit will be issued by City Staff at City Office, for residents only.
- Permit is good from January 1st to December 31st
- Permits are for personal use only; sale of firewood is prohibited.
- Permit is good for dead and downed wood only.

It is the City's right to revoke ROW Firewood Permit privileges at any time if any of the above policy is violated.
