CITY OF COFFMAN COVE, ALASKA ORDINANCE 18 02

AN ORDINANCE AMENDING SECTION 10.03.100 OF THE COFFMAN COVE CODE OF HARBOR ORDINANCES TO REMOVE AND ADD LANGUAGE UNDER SUBSECTION (B) AND (C) AND REPEALING SUBSECTION (D).

BE IT ENACTED BY THE COFFMAN COVE CITY COUNCIL AS FOLLOWS:

Section 1, Classification. This ordinance is of a general and permanent nature and the adopted amendment shall become a part of the Coffman Cove Code of Ordinances.

Section 2. Severability. If any provision of this ordinance or any application thereof to any person or circumstance is held to be invalid, the remainder of this ordinance and the application to other persons or circumstances shall not be affected thereby.

Section 3. Effective Date. This ordinance is effective upon adoption.

Section 4. Section 10.03.100(B) is amended to read:

Section 10.03.100 Use of boat launch ramp.

B. No moorage is allowed at the boat launch. This area is strictly for loading and unloading boats from trailers. No boat shall be tied up for longer than 15 minutes except as may be otherwise provided under D below.

Section 5. 10.03.100(C) is amended to read:

Section 10.03.100 Use of boat launch ramp.

C. Boat launch ramp users shall obey all boat launch ramp rules and regulations as established from time to time by the harbormaster or City Council. Such rules and regulations will be referred to as the "Boat Launch Ramp Rules and Regulations". The Boat Launch Rules and Regulations shall be set out in writing and (i) posted at a conspicuous place at or near the City Harbor and (ii) placed on file with the City Clerk Administrator. Violators are subject to the enforcement provisions of this title as well as prosecution under the aforementloned laws.

Section 5. Section 10.03.100(D) is repealed:

D. — City may enter into a "Ramp Use Agreement" with the North End Port Authority (herein. Authority") for use of the boat launch ramp for purposes of loading and off-loading passengers and vehicles, and refueling the Authority's vessel. A Ramp Use Agreement shall be in writing, approved by the City Gouncil, and require that (i) Authority indemnify City from against all claims from injury to persons or property resulting during Authority's use of the boat launch ramp, and (ii) city be named as an "additional insured" on Authority's liability insurance.
