

**City of Coffman Cove  
Ordinance 17-01**

**AN ORDINANCE OF THE CITY OF COFFMAN COVE PROHIBITING THE OPERATION OF MARIJUANA CULTIVATION FACILITIES, THE OPERATION OF LICENSED RETAIL MARIJUANA STORES, THE OPERATION OF LICENSED MARIJUANA PRODUCT MANUFACTURING FACILITIES**

**Section 1. Purpose.**

To add, delete and amend the language of Title VIII Public Health and Safety.

**Section 2. Classification.**

This Ordinance is of general and permanent nature and shall become part of the Municipal Code.

**Section 3. Prior Ordinance superseded.**

This Code supersedes any and all Ordinances adopted prior to this code and not included within this Code at the time of this Code's adoption.

**Section 4. Severability.**

If in any provision of this Ordinance or application thereof to any person or circumstance is held invalid, the remainder of this Ordinance shall not be affected thereby.

**Title VIII Public Health & Safety**

**Chapter 8.05 Marijuana**

**Sections 8.05.010 Prohibiting the Operation of Marijuana Cultivation Facilities in Coffman Cove.**

**Section 8.05.020 Prohibiting the Operation of Licensed Retail Marijuana Stores in Coffman Cove.**

**Section 8.05.030 Prohibiting the Operation of Licensed Marijuana Product Manufacturing Facilities in Coffman Cove.**

Chapter 8.05 Marijuana

Section 8.05.010 Prohibiting the Operation of Marijuana Cultivation Facilities in Coffman Cove.

The City of Coffman Cove prohibits the operation of licensed marijuana cultivation facilities. Prohibiting any marijuana cultivation facility or entity registered to cultivate, prepare, and package marijuana.

Section 8.05.020 Prohibiting the Operation of Licensed Retail Marijuana Stores.

The City of Coffman Cove prohibits an entity registered to purchase marijuana from a marijuana cultivation facility, to purchase marijuana and marijuana products from marijuana product manufacturing facilities, and to sell marijuana and marijuana products to consumers.

Section 8.05.030 Prohibiting the Operation of licensed marijuana product manufacturing facilities.

The City of Coffman Cove prohibits an entity registered to purchase marijuana: manufacture, prepare, and package marijuana products.
